Medal of Honor Winners of the War in Vietnam



JACOBS, JACK H.



Rank and organization: Captain, U.S. Army, U.S. Army Element, U.S. Military Assistance Command, Republic of Vietnam. Place and date: Kien Phong Province, Republic of Vietnam, 9 March 1968. Entered service at: Trenton, N.J. Born: 2 August 1945, Brooklyn, N.Y. Citation: For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. Capt. Jacobs (then 1st Lt.), Infantry, distinguished himself while serving as assistant battalion advisor, 2d Battalion, 16th Infantry, 9th Infantry Division, Army of the Republic of Vietnam. The 2d Battalion was advancing to contact when it came under intense heavy machine gun and mortar fire from a Viet Cong battalion positioned in well fortified bunkers. As the 2d Battalion deployed into attack formation its advance was halted by devastating fire. Capt. Jacobs, with the command element of the lead company, called for and directed air strikes on the enemy positions to facilitate a renewed attack. Due to the intensity of the enemy fire and heavy casualties to the command group, including the company commander, the attack stopped and the friendly troops became disorganized. Al-

though wounded by mortar fragments, Capt. Jacobs assumed command of the allied company, ordered a withdrawal from the exposed position and established a defensive perimeter. Despite profuse bleeding from head wounds which impaired his vision, Capt. Jacobs, with complete disregard for his safety, returned under intense fire to evacuate a seriously wounded advisor to the safety of a wooded area where he administered lifesaving first aid. He then returned through heavy automatic weapons fire to evacuate the wounded company commander. Capt. Jacobs made repeated trips across the fire-swept open rice paddies evacuating wounded and their weapons. On 3 separate occasions, Capt. Jacobs contacted and drove off Viet Cong squads who were searching for allied wounded and weapons, single-handedly killing 3 and wounding several others. His gallant actions and extraordinary heroism saved the lives of 1 U.S. advisor and 13 allied soldiers. Through his effort the allied company was restored to an effective fighting unit and prevented defeat of the friendly forces by a strong and determined enemy. Capt. Jacobs, by his gallantry and bravery in action in the highest traditions of the military service, has reflected great credit upon himself, his unit, and the U.S. Army.

One of the few to ever escape as a POW

James N. Rowe was assigned as Executive Officer of Detachment A-23, 5th Special Forces, a 12-man "A-team" in Vietnam in 1963. Located at Tan Phu, A-23 organized and advised a Civilian Irregular Defense Group camp in the Mekong Delta region of Vietnam. On October 1963, after only three short months in the Republic of Vietnam, then-Lieutenant Rowe was captured by Viet Cong elements along with Captain Humberto "Rocky" Versace, and Sgt. Daniel L. Pitzer.. Separated from his comrades, Lt. Rowe spent 62 months in captivity with only brief encounters with fellow American POWs. He escaped from his Vietnamese captors on December 31 1968. Rowe had been promoted to Major during his captivity. He authored the book, *Five Years to Freedom*, an account of his years as a prisoner of war.



Colonel Rowe retired from the U.S. Army in 1974. In 1981, he was recalled to active duty to design and build a course based upon his experience as a POW. *Survival, Evasion, Resistance, and Escape* (SERE) is now a requirement for graduation from the U.S. Army Special Forces Qualification Course. SERE is taught at the Colonel James "Nick" Rowe Training compound at Camp Mackall, NC. It is considered by many to be the most important advanced training in the special operations field. Navy, Air Force and Marine Special Operations personnel all attend variations of this course taught by their respective services.

Damages Awarded In USS Pueblo Case

A federal judge awarded more than \$65 million to several men who were captured and tortured by North Korea after the communist country seized the U.S. spy ship USS Pueblo in 1968. In entering the judgment against North Korea, which never responded to the lawsuit, U.S. District Judge Henry H. Kennedy Jr. called the abuse of William Thomas Massie, Dinnie Richard Tuck, Donald Raymond McClarren and Lloyd Bucher "extensive and shocking." Bucher, the ship's captain, died in 2004. The ship is still in North Korean hands.

TAPSLt. General Victor H. Krulak**Vietnam War**

Krulak was responsible for all Fleet Marine Force units in the Pacific, including some 54 trips to the Vietnam theater. At the beginning of the War, Krulak put forward the "Spreading Inkblot Theory." This promoted a spreading inkblot of small units actions to pacify South Vietnam village by village. When large enemy units were encountered then General Westmoreland's overwhelming firepower should be employed. He also called for intensive bombing of North Vietnam and mining of Haiphong Harbor. Krulak's plans were eventually rejected as Westmoreland favored hammering the enemy into submission through superior firepower and the Johnson administration feared relentless bombing of the North would provoke Soviet and Chinese intervention..



Krulak's medals and decorations include: the Navy Cross, the Navy Distinguished Service Medal, the Legion of Merit with Combat "V" and two Gold Stars in lieu of second and third awards, the Bronze Star, the Air Medal, the Purple Heart, the Presidential Unit Citation with three bronze stars indicative of second through fourth awards, the China Service Medal with one bronze star, the American Defense Service Medal with Base clasp, the American Campaign Medal, the Asiatic-Pacific Campaign Medal with three bronze stars, the World War II Victory Medal, the Navy Occupation Service Medal with Asia clasp, the National Defense Service Medal with one bronze star, the Korean Service Medal with four bronze stars, the Vietnam Service Medal, the United Nations Service Medal, the Korean Order of Service Merit second class, the Republic of Vietnam National Order Medal third class, the Republic of Vietnam Gallantry Cross with Oak Leaf Cluster, two Korean Presidential Unit Citations, and the Republic of Vietnam Campaign Medal.

Why al-Qaida Isn't Gaining A Foothold In Cambodia

A unique confluence of modern history, geography, and government initiative have combined to foster religious tolerance in Cambodia, where Muslims and non-Muslims live side by side in harmony, their existences unmarred by the toxic cocktail of government repression, separatist ambitions, and growing radicalism characteristic of many neighboring countries. Cambodia's unique and dark modern history helps explain why the dominant form of Islam remains both peaceful and accommodating, Muslim leaders say. When the ultra-Communist Khmer Rouge seized power in 1975, they outlawed religion and set about decimating the Muslim population. As a result, the violence of al-Qaida today reminds Muslim leaders of the Khmer Rouge of yesterday.

Army alerts feds of possible Stolen Valor case

Discrepancies in the service record of a Vietnam veteran seeking a Medal of Honor have prompted the Army to alert the FBI of a potential violation of the Stolen Valor Act, sources close to the investigation said. The case involves Terry Richard Calandra, 59, of Forks Township, Pa., who is commander of the Military Order of the Purple Heart Chapter 700 in Glen Gardner, N.J.

“After review of Mr. Calandra’s records, a number of potential discrepancies were noted and the matter was referred to civilian law enforcement for investigation of the potential violation of the Stolen Valor Act,” said Lt. Col. Richard McNorton, a spokesman for Human Resources Command. The legislation, signed into law in 2006, makes falsely claiming a military decoration or medal a misdemeanor punishable by up to a year in jail and/or a fine.



An investigator for the FBI declined to comment on the case. Calandra said he was “baffled” by the Army’s action. “All I know is I had eyewitness accounts on this,” he said. “I’m going to stand on my military record. . . . If the Army wants to change their mind, that’s their business. I’ll send my medals back. I don’t need them.” Calandra’s discharge paperwork states he received the Distinguished Service Cross, the military’s second-highest award given for “extraordinary heroism in action against an enemy,” as well as the Silver Star, Bronze Star with “V” device for valor (second oak leaf cluster), Purple Heart (fourth oak leaf cluster), the Army Commendation Medal with “V” Device for valor (first oak leaf cluster) and other decorations from a six-month tour in Vietnam in 1969, according to portions of his service record provided by the National Personnel Records Center in response to a Freedom of Information request from Army Times. The general orders and citations in Calandra’s official service record for the two highest awards — the Distinguished Service Cross and the Silver Star — conflict with records at the National Archives and Records Administration, according to copies of the documents obtained by Army Times.

General orders are issued by various commands to announce awards, among other news, and are published in chronological order in a given year.

In Calandra’s file, the U.S. Army Vietnam general order announcing his Distinguished Service Cross is numbered 9,580. According to the National Archives, U.S. Army Vietnam only issued 4,519 general orders in 1969. The most general orders USARV ever issued in any year during the conflict was 7,149 in 1966. In Calandra’s file, the 9th Infantry Division general order announcing his Silver Star is numbered 5,293. That general order number corresponds to one at the National Archives announcing a posthumous award of the Army Commendation Medal for a different soldier, Spc. Larry Brown. The documents contain other inconsistencies. The Army most recently began reviewing Calandra’s file in August after U.S. Sen. Arlen Specter, R-Pa., forwarded an inquiry from Calandra about his Medal of Honor nomination.

“Mr. Terry Calandra has contacted my Allentown office inquiring on the status of his nomination for the Congressional Medal of Honor,” Specter wrote in a July 18 letter to the Military Awards Branch. “Since the request falls under your jurisdiction, I have forwarded you a copy of his request.”

Specter later told a local newspaper editorial board that Calandra should be considered for the military’s top award. In an e-mail to Army Times, spokesperson Kate Kelly said, “Sen. Specter’s office has been briefed by the Army concerning the questions surrounding Mr. Calandra’s service.” She declined further comment.

In October, Pennsylvania state Rep. Richard T. Grucela introduced a resolution “memorializing the Congress of the United States to award Terry Calandra the Medal of Honor for valorous service during the Vietnam Conflict.” The bill, which was co-signed by dozens of representatives, died in committee. Grucela’s office didn’t return a call seeking comment.


